ORDINANCE NO. 0- 247 -98

AN ORDINANCE OF THE LAFAYETTE CITY-PARISH COUNCIL ESTABLISHING VOTING PRECINCT BOUNDARIES ON BEHALF OF THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT TO COMPLY WITH THE MANDATES OF ACT 1420 (1997 REGULAR SESSION) WHICH REQUIRES THE ESTABLISHMENT OF VISIBLE PRECINCT BOUNDARIES

BE IT ORDAINED by the Lafayette City-Parish Council that:

WHEREAS, Act 1420 (1997 Regular- Session) mandates that all precincts, with rare exceptions, have visible precinct boundaries; and

WHEREAS, pursuant to Resolution R-004-99, the Lafayette City-Parish Council authorize the Registrar of Voters, in concert with the Lafayette City-Parish Consolidated Government through the Department of Planning, Zoning and Codes to prepare and submit a preliminary proposal to the State of Louisiana for its review and consideration in order to comply with the mandates of Act 1420 (1997 Regular Session); and

WHEREAS, the State of Louisiana has now approved the submission made by the Lafayette Parish Registrar of Voters and has confirmed that the submission satisfies the visible feature requirements of Act 1420; and

WHEREAS, it is now necessary to adopt an Ordinance to establish these visible precinct boundaries and, furthermore, that after said Ordinance pre-cleared is necessary to have the Ordinance pre-cleared by the United States Department of Justice so that the proposed precinct changes may be implemented; and accordingly,

NOW THEREFORE BE IT ORDAINED by the Lafayette City-Parish Council:

SECTION 1: All of the "Whereas" clauses are incorporated herein and adopted as part of this Ordinance.

SECTION 2: The Lafayette City-Parish Council does establish voting precinct boundaries on behalf of the Lafayette City-Parish Consolidated Government to comply with the mandates of Act 1420 (1997 Regular Session) which requires the establishment of visible precinct boundaries.


SECTION 3: The voting precinct boundaries are as reflected ill Exhibit "A" which is a map of all precincts indicating boundaries and numbered designations which map is on file ill the office of the Clerk of the Council; as is reflected in Exhibit "B" which is a written description of each precinct boundary, which is a written description is on file in the office of the Clerk of the Council, and as is reflected in Exhibit "C" which is a list of all polling locations assigned to each precinct, which list is on file in the office of the Clerk of the Council.

SECTION 4: These precinct changes shall be effective not later than January 1, 2000, for the purpose of establishing block boundaries for the 2000 Census and for reapportionment purposes, and not later than December 31, 2001, for all purposes.

SECTION 5: This Ordinance once adopted, shall be submitted for pre-learance by the United States Department of Justice under the voting rights Act of 1965, as amended, so that the proposed precinct changes may be implemented for the 2000 Census.

SECTION 6: All Ordinances or Resolutions or parts thereof, including, but not limited to all ordinances or Resolutions or parts thereof of the City of Lafayette and/or the Parish of Lafayette, if any, in conflict herewith are hereby repealed.

Having briefed City-Parish Council members on ACT 1420 (1997) requirements and presented prospective future precinct boundaries to comply, I was then requested and authorized by the attached Council Resolution #R-044-98 to go forth with a submission of the proposed visible boundaries to the State of Louisians for review and approval as mandated by the Act.

The attached letter dated June 2, 1998 from the House of Representatives indicates approval of the State of Louisiana for the prospective precincts submitted to comply with ACT 1420 of 1997, ensuring that precinct boundaries conform to the census boundaries and meet the visible feature requirements.

The letter further indicates that A FINAL PASSAGE ORDINANCE is now needed which officially adopts the boundaries of all precincts submitted and approved, as well as, a preclearance letter by the U.S. Department of Justice (by December 31, 1998 at the latest), so that the precincts may be implemented for the 2000 census.

The letter also recommends two (2) effective dates to be used in the ordinance.

The ordinance should adopt the establishment of ALL voter precincts in the Parish of Lafayette, prescribing their boundaries, defining their territorial limits, designating numerical precinct references, designating their polling locations, and establishing the effective dates in accordance with ACT 1420 of the 1997 regular session of the Louisiana legislature.

Hopefully, the following ENCLOSURES will help as exhibits:

- 1. A MAP OF ALL PRECINCTS INDICATING BOUNDARIES AND NUMBER DESIGNATIONS.
- 2. A WRITTEN DESCRIPTION OF EACH PRECINCT BOUNDARY.
- 3. A LIST OF POLLING LOCATIONS ASSIGNED TO EACH PRECINCT.

The Office of the Clerk of the House of Representatives has reviewed your submission on behalf of Lafayette Parish proposing changes to precinct boundaries to comply with Act 1420's requirement that nonvisible precinct boundaries be changed to visible features. This submission satisfies the visible feature requirements of Act 1420 and is approved by this office.

We understand that this submission establishes these precinct changes as "prospective" changes as provided by R.S. 18:532.1 (B). This "prospective" submission indicates that these precinct changes shall be effective not later than January 1, 2000, for the purpose of establishing block boundaries for the 2000 Census and for reapportionment purposes, and not later than December 31, 2001, for all purposes. The final version of the parish's ordinance regarding these precinct changes should indicate these effective dates.

Be advised that this approval is for the current submission only and that any changes to this current submission must be subsequently approved by this office. Furthermore, a copy of the final passed ordinance regarding these precinct boundary changes must also be provided. Finally, this office must also receive documentation of preclearance by the United States Department of Justice by December 31, 1998, so that the proposed precinct changes may be implemented for the 2000 Census.
