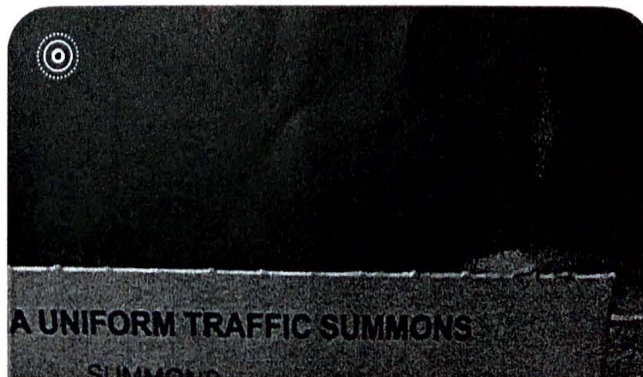
I hope not but he just insisted that they are turning everything over to the Parish. I'll just wait until we get cited & let you know.
